5:1 Statutes, Ordinances, Regulations & Rules

- (i) Amendment of Clause (3) of Statute 3
on the Pay and Allowances of the
Pro-Vice-Chancellor.

In terms of Clause (3) of Statute 3, every Pro Vice Chancellor shall be paid a monthly salary in the Scale of Rs.5900-200-7300 subject to a minimum of Rs.6500/-P.m or in such scales as may be prescribed from time to time and also shall be entitled to such other allowances as are admissible to University employees from time to time.

According to the Revision of V Pay commission the Scale of the Pro-Vice-Chancellor has been enhanced to Rs.18400-500-22400 with effect from 1.1.96 subject to a minimum of Rs.19,900/- P. m.

The matter was placed before the 9th Emergent meeting of the Executive Council for consideration and approval and the Council approved the Scale of the Pro-Vice-Chancellor alongwith other allowances as are admissible to University employees from time to time.

Hence, the existing Clause (3) of Statute 3 require to ammend accordingly as follows.

Every Pro-Vice-Chancellor shall be paid a monthly salary in the scale of Rs 5,900-200-7300 subject to a minimum of Rs.6500/-P.m. or in such scale as may be prescribed from time to time and he shall be entitled to such other allowances as are admissible to University employees from time to time.	The Pro-Vice-Chancellor be given the new pay scale of Rs.18400-500-22400 with effect from 1.1.96 and the minimum be fixed at Rs.19,900/-P.m. or in such scale as may be prescribed from time to time and he/she shall be entitled to such allowances as are admissible to University employees from time to time.

The matter is placed before the Council for consideration.
