

- (ix) Appointment of a Lecturer in the Department of Linguistics on contract basis.

The Head Department Linguistics vide letter of even No. 503 dt. 26.8.99 (Annexure - A) has informed that she had engaged Ms. S.A. Lyngdoh to start teaching in the Department with effect from the month of August 1999 in place of Ms. N.S. Mukherjee who had since vacated the post following the expiry of the term of contract appointment for a period of one year on 28.5.99 against the floating post.

In this connection it may be stated that Ms. S.A. Lyngdoh is a Gold Medalist and an M.Phil from Delhi University. She is good in the area of Syntax & typology and is indeed the requirement of the Department in which the two existing faculty cannot cope with teaching of these two courses. On examination of her biodata it is found that she obtained 74.19% in M.A. Linguistics and also cleared the UGC NET Test (Biodata at Annexure -B). She has therefore fulfilled the requisite qualifications for appointment as Lecturer laid down under 4-A of RE-4. Under Cl.2 of RE-3 subject to provision of the Act, Statutes & Ordinances the Executive Council is empowered to make contract appointment against floating post and against vacant teaching post in the teaching cadre namely, Professor, Reader & Lecturer for furthering the cause of academic life & programme of the University.

Considering the dire need of the Department having only one Professor and one Reader, the Executive Council may kindly approve and ratify the engagement of Ms. S.A. Lyngdoh on contract basis w.e.f August 1999 for a period of one year against a floating post as done in the case of Ms. N.S. Mukherjee. It is submitted that the case of Ms. S.A. Lyngdoh has become a connected liability since she is already engaged w.e.f August 1999.

The matter is therefore placed before the Council for kind . . . ratification of the action taken.
