

(xv) . Extension of Lien to Dr. G.D. Sharma,  
Reader in Botany.

The Executive Council vide resolution No:EC:90:96:3:(i) held on 18.7.96, approved the lien granted to Dr. G.D. Sharma Reader, for a period of one year w.e.f. 28.5.96(A.N.).

Before the expiry of the lien period on 27.5.97, the Vice-Chancellor, Assam University vide his letter dt. 11.4.97, forwarded the application of Dr. G.D. Sharma for extension of lien for 1(One) year more with his request to consider the application sympathetically.

The application of Dr. G.D. Sharma was forwarded to the Head, Botany Deptt., requesting for his views and comments but the Head stated that in the interest of the Department, particularly its academic programme it would not be desirable to block one post of Reader for a period of 2 years by extending leave to Dr. Sharma.

Since as per the rule, lien can be granted to permanent Government servant for a period of 2(Two) years and Dr.G.D. Sharma is a permanent employee of the University, the Vice-Chancellor approved the extension of lien for another period of one year w.e.f. 28.5.97 indicating therein that he should either revert to this University within the said period or resign on the expiry of the lien.

In view of above, the matter is reported to the Executive Council for ratification.
