(iv) Offer of 'P' Type quarter to Prof. R.L. Walli

In pursuance of the E.C Resolution No.91:96:6:7:(iii) in its meeting held on 7.12.96 which resolved that the Professor occupying the L/Type quarter may be offered the 'P' Type quarter in turn and be given 15 days time to move into the quarter. In view of the above Resolution, the office has requested Dr Walli to vacate his quarter and to occupy 'P' type quarter. This may be seen at Annexure-I. In response to our letter, Dr Walli has stated that the L/Type quarter No.8 will still be retained by him.

The matter was placed before the RAC meeting which held on 27.6.97 which rejected the application of Dr Walli and resolved the issue with certain conditions. This may be seen at Annexure-II.

Prof. R.L. Walli vide his letter has stated that 'P' Type quarter allotted to him may be offered to the twenty two Professors who are at present occupying the L/Type quarter. Annexure-III.

The matter is placed before the E.C for consideration.

ANNEXURE-I

- (iii) House Allotment and retention of quarter by the re-employed teachers.

No.EC:91:96:6:7:(iii) : The Council deliberated on the House Allotment Rules and RESOLVED that the Professors occupying the L-type quarters may be offered the P-Type quarter in turn and be given 15 days time to move into the quarter failing which the matter will be reported to the Executive Council.

ANNEXURE-III

Extract of the Minutes of the Residence Allotment Committee meeting held on 27.6.97.

The Committee deliberated on the items placed before it and resolved as follows:-

- 1.(c) - The Committee rejected the representation submitted by Prof.R.L.Walli and resolved that:

- (i) He should shift to the P/Type quarter No. 'D' within fifteen days time from the date of issue of the letter failing which the P-Type quarter will be allotted to the next senior Professor.

- (ii) Rent should be charged as per rule from Prof.R.L.Walli for the un-authorized occupation of L/Type quarter No.8.

- (iii) Allotment of L/Type quarter No.8 is temporarily cancelled and kept in abeyance.

EXTRACT TAKEN FROM THE MINUTES OF THE
RESIDENCE ALLOTMENT COMMITTEE HELD ON
27.6.1997.

Item No. 1.(c) The Committee rejected the representation submitted by Prof. R.L. Walli and resolved that :

- (i) He should shift the P/type quarter No.'D' within fifteen days time from the date of issue of the letter failing which the P/type quarter will be allotted to the next senior.
- (ii) Rent should be charged as per rule from Prof. R.L. Walli for the un-authorized occupation of L/type quarter No.8.
- (iii) Allotment of L/type quarter No.8 is temporarily cancelled and kept in abeyance.

(iii) Proposed amendment on the House Allotment Rules.

NO:EC:93:97:6:7:(iii): The Council considered the proposed amendment of the House Allotment Rules as recommended by a Committee appointed by it and RESOLVED to approve the same with the following modifications :

'Under Section 2(h) "Allotment Seniority" after the first para it should also be added that 'For the purpose of these Rules, the Statute 26(i) applies to station seniority of respective Campuses'.

'Under Section 6-"Other categories of allotment"the House Allotment Rules should read as under :-

(a) The following categories of employees shall be entitled to allotment subject to availability of vacancies in RUAB quarters:-

- (i) Employees of the Essential services
 - (ii) Visiting Teachers
 - (iii) Employees on contractual appointments
 - (iv) Physically handicapped employees
 - (v) Employees appointed on compassionate grounds
- (b) Employees coming from different NEHU Campuses for administrative reasons.

Note :

- (i) Such allotments shall be made by the Vice-Chancellor
- (ii) The allotments shall Ordinarily not exceed 10% of residences in different types, provided that in case a person holding an essential post is transferred, he/She may be given six months notice to vacate the accomodations.

(iv) Offer 'P' Type quarter to Prof R L Walli.

No:EC:93:97:6:7(iv) The Council RESOLVED ~~That~~ Prof Walli should shift to P.Type quarter within 15 days, with effect from the date of notice failing which he has to vacate the L-Type quarter without delay.
