This is to state that the Treasury Officer in the Office of the Deputy Commissioner, Aizawl District, Aizawl is all along entrusted to keep the Confidential packets of Under Graduate Examinations of the Colleges for safe custody of the same in the Treasury and then handed over the same to the Colleges on the Examination days. The nominal remunerations was also used to be paid to them at the approved rates from time to time.
