

(viii) Appointment as head, Centre for Literary and
Cultural Studies.

Dr. Soumen Sen, was appointed as Head, Centre for Literary and Cultural Studies for a period of 3 years w.e.f 11.11.94 vide Notification No.F.5-5/XXXVII/ Estt.II/ 90-5639 dt.23.2.95.

Dr. Soumen Sen has retired on 31.10.97 and has ceased to be the head of the Centre.

Shri. P. Jhingan is the only lecturer in the Centre for Literary and Cultural Studies.

In terms of Statute 7 (2) of the NEHU Act 1973 only Professor and Reader can be recommended by the Vice-Chancellor to the Executive Council for appointment as Head of the Deptt. In absence of the head of the Department it is difficult for the Department to run the work of the Department.

The matter is therefore, placed before the EC for consideration whether the lecturer can be appointed as Teacher in-charge as there is no provision in the Statute.
