- xiii) Extension of deputation in respect of Shri L. Nampui, Finance Officer, NEHU, Shillong.

The term of deputation of Shri L. Nampui for a period of three years expired on 16.11.98. Shri Nampui submitted his willingness to continue on deputation as Finance Officer for another one year provided that the parent department's consent is obtained. Considering the above and also as the exigencies of service demanded him to continue to the post as the University had not been able to fill the post of Finance Officer on regular basis, his parent department has been moved accordingly for extension of one year with effect from 17.11.98 under letter at Annexure - I.

Secondly, Shri L. Nampui was promoted to the Senior Administrative Grade of Indian Revenue Service in the grade of Commissioner of Income Tax in the scale of Rs.18,400-500-22,400/- vide Govt. of India, Ministry of Finance, Department of Revenue's order No.121 of 1997 and No.125 of 1998 respectively - Annexure -II. The matter has been examined by the office and the Vice-Chancellor, NEHU was pleased to allow Shri L. Nampui to draw the promotion scale of 18,400-500-22,400/- effective from the date of promotion in parent department with effect from 20.9.97 to the said grade on adhoc basis under the next below rule on joining of his junior in the CIT cadre in the parent department, i.e., 20.9.97.
