The Council further RESOLVED that :

1. The Inspection Team shall submit its report to the Affiliation Committee which will then place its recommendations before the Academic Council.
2. TA / DA to the members of the Governing Bodies shall be borne by the individual Colleges.
3. The dates of meetings of the Governing Body as well as the Selection Committees shall be fixed in consultation with the University.
4. The list of University Teachers to be considered as Members of the Selection Committees in the Colleges shall be forwarded to the Colleges by the Director, College Development Council.
5. For the purpose of selecting teachers for the Affiliated Colleges, NET qualified candidates only should be considered.
6. The Mizoram Government is requested to inform the University about the norms required by the University for developing the Under-graduate education.
7. The University is to take up with the NET Council, UGC for the opening of a Centre for NET examinations at Aizawl.

The Council also considered the Report of the Inspection Team in respect of the St. Dominic College, Shillong and observed that since the College has failed to appoint a qualified Principal, and also of attempting to mislead the University by falsely producing someone as a permanent Librarian when in actual fact the person concerned was appointed only for three days on daily wage basis, the Council unanimously RESOLVED that the College be asked why the privileges granted to it should not be withdrawn.
