The Executive Council at its 90th meeting held on 18.7.96 vide resolution No.:EC:90:96:6:2:(xvi) considered the confirmation of service of Dr.S.N.Rai as Director, Computer Science and Resolved that since the post is an executive post and his Annual Confidential Reports have not been recorded, the Council authorised the Chairman to take action after the annual confidential Reports have been recorded.

In view of the above decision, Dr.S.N.Rai have been requested to fill up the ACR's and the same have been submitted by him for the period from 1993 to 94, 1994 to 95 and 1995 to 96 and forwarded to the P.S. to Vice-chancellor for reviewing & accepting the ACR.

As per order in the file it appears that Dr. S.N.Rai has no adverse remarks in his ACR's and the Vice-chancellor, has approved the confirmation of service of Dr.S.N.Rai as a Director in Computer Science, w.e.f.19.8.1993, the date of joining as Director. The lien hold by him against the post of Reader in Chemistry stands terminated w.e.f. the date of confirmation, i.e.19.8.93.
