Dr. Mubarak Hussain was released by the Principal Pachhunga University vide order No. PUC PF/TS/98/4455 dt. 6/12/1990 (anexure I) from 10/12/90 (FN) to enable him to join his new post at North Eastern Regional Institute of Science & Technology Itanagar. The matter was taken up in the 70th Executive Council to consider the release of Dr. Hussain with effect from 16/12/90, as the Principal, vide his letter No PUC/PF/TS/98/3952 dt. 13th, Sept, 1990 (anexure II) had intimated that due to pressure of work he can not be released before 15/12/90. The Executive Council accordingly vide resolution No:70:90:3:(xv): approved the release of Dr. Hussain with effect from 16/12/90.

Secondly, the technical resignation of Dr. Mubarak Hussain was also accepted by the Executive Council with effect from 16/12/90 and an order dt. 13/1/94 was issued accordingly by the office. However in view of the Principal Pachhunga University College vide letter dt. 6/12/90 Dr. Mubarak Hussain was released from 10/12/90 (FN) and the office had re-examined the matter for which his technical resignation will have to be effected from 10/12/90 instead of 16/12/90 which has been accepted by the Vice-Chancellor and the matter is placed before the Executive Council for ratification.
