

(xiv) PROPOSAL FOR POSTING OF THE NON-TEACHING GROUP 'B' 'C' AND 'D' STAFF OF ERSTWHILE NAGALAND CAMPUS.

Out of the 74 Group 'B' 'C' and 'D' employees of the erstwhile NEHU Nagaland Campus opted for NEHU, 27 of them are waiting for posting. The list of such employees are shown in Annexure 'A' for reference of the Council.

During the posting of staff for Tura Campus, 1(one) UDC, 1(one) LDC and 4(four) peons were drawn from amongst the headquarters staff and no replacement was made as yet. It is suggested that the replacement requirement may be met from the UDC's, LDC's and Peons waiting for posting. The replacement requirement for peons is 4(four) while the peons under waiting for posting are only 3(three) - 2(two) of those are under consideration for permanent absorption in Nagaland University.

Further, with the placement of the departments of Linguistics and Commerce in Shillong, the establishment of the departments of Garo in Tura Campus, the following staff requirement is yet to be met.
