

ITEM FROM THE CHAIR

Appointment of Head of the Department of Political Science

Prof. A.K.Baruah was appointed as Head of the Department of Political Science w.e.f 16.12.2005 for a period of three years. Meanwhile, a letter dated 21st June, 2007 (vide **Annexure-A**) has been received from Prof. A.K.Baruah requesting the University to relieve him from Headship for the reason already explained in the letter. As a sequel to this, it has become imperative to consider appointment of another Head vice Prof. A.K.Baruah.


(iii) Case of Shri X P Mao, Lecturer, Department of Philosophy
