

(141) GRANT OF E.O.L. IN RESPECT OF PROF. J.C. BINWAL, DEPARTMENT OF LIBRARY & INFORMATION SCIENCE, NEHU, SHILLONG.

Prof. J.C. Binwal vide his letter Lib.Sc/PF/JCB-2 -3 (1) 96 dated 4th April '96 informs the University that he has been invited by Sana' a Yemen Arab Republic to help them start and set up the Department of Library & Information Science for a period of two years.

Prof. Binwal is willing to accept the appointment and has therefore applied E.O.L. for 2 years w.e.f. 1.10.96 to 30.9.98. As the Head of the Department, Prof. Binwal states that his Department will soon appoint 3 (three) teachers (1 Reader & 2 Lecturers) and the Department will be strengthened with the appointment of the teachers.

The request of Prof. Binwal for grant of E.O.L. has been approved by the Vice-chancellor and the matter is placed before the Council for kind consideration & ratification.
