Efforts were also made by the University to fill up these posts through open advertisement, but due to lack of qualified candidates these posts remain unfilled till date.

However, in order to conduct regular PG. Diploma Course in Painting in the Centre, the Head of the Centre, vide his letter at **ANNEXURE-'A'** has requested the University to consider re-appointment of Shri. B. Kalita as Visiting Fellow for the academic session commencing from 19th February, 2008.

Considering the need of the Centre and the interest of the students community, the Vice-Chancellor, subject to the ratification by the Executive Council approved the appointment of Shri. B. Kalita as Visiting Fellow for the current semester commencing from 19.02.2008 to 31.07.2008 or till the date of appointment of regular incumbent which ever is earlier. 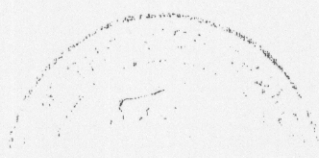

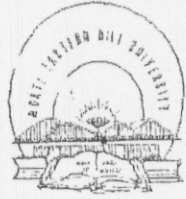
