It may be mentioned herein that prior to assumption of charge of Estate Officer by Smti. B. Bareh, Dr. Khongsdier, Reader, in the Department of Anthropology was holding the additional charge of Estate Officer of the University and for which Dr. Khongsdier has been paid an honorarium of Rs.800/- p.m. In the light of this, Smti. B. Bareh has made a request to the University to consider for payment of honorarium, as made applicable to Dr. Khongsdier. A letter of request from Smti. B. Bareh is placed at (Annexure - D).

Further, a copy of the notification No.F.18-1/Admn/Honor/99-449 dated 12.05.2000 containing various rates of monthly honorarium payable for additional assignments is placed at (Annexure - E).

The matter is placed before the Council for consideration.




