Dr I. Hussain, Sr. Medical Officer, N.E.H.U., Shillong vide letter dated 23.5.98 (Annexure - I) has requested for grant of annual allowance of Rs.3000/- per annum on completion of the P.G. Diploma Course in Hospital and Health Management for a period of one year from January, 1991 to December, 1991 conducted by the Academy of Hospital Administration, New Delhi (Annexure - II) and awarded the P.G. Diploma Certificate (Annexure - III).

In terms of the Ministry of Health & Family Welfare, Government of India letter No.A.27023/3/87/CHS.V dated 22.12.89 (Annexure- IV) all Medical Officers holding P.G. qualification either Diploma or Degree will be paid an annual allowance of Rs.3000/- per annum.

It may be mentioned that Dr. V.S.V. Prasad, Sr. Medical Officer was granted Rs.3000/- per annum vide E.C. resolution No.EC:96:98:6:6(ii) for holding similar qualification in terms of the above stated Government of India letter dated 22.12.89.

In view of the Government of India Order dated 22.12.89, Dr I. Hussain is found to be entitled to an annual allowance of Rs.3000/- per annum at the rate of Rs.250/- per month with effect from 1.1.92.
