

11 (viii) Enhancement of honorarium to guest lecturer.

The Executive Council in its meeting vide EC resolution No. EC:104:99:8(VI) held on 12.10.99 has resolved that the University may pay an honorarium of Rs.150/- per lecture subject to a maximum of Rs.4500/- per month. But the Commission's vide letter dt.21.3.2000 (Annexure I) has decided to enhance the amount of honorarium to guest lecturer from Rs.150/- to Rs.250/- per lecture. The Commission's letter dt. 12.10.99 (Annexure-II) has stated that there is no ceiling on payment of honorarium to guest lecturer but work assigned to guest teachers should not be more than three hours teaching per day and 18 hours per week.

In view of the enhancement by the Commission of the revised rate the matter is therefore placed before the Council for consideration of the ceiling limit and the enhanced rate for guest lecturer.
