

- (v) Proposal for appointment on contract basis to the Department of Garo, Tura Campus.

The Pro-Vice-Chancellor NEHU, Tura Campus, vide his letter dated 21.5.99, forwarded the proposal made by the Head Department of Garo for appointment of Prof. S.N. Goswami on contract basis alongwith the biodata of Prof. S.N. Goswami.

The Department of Garo at Tura Campus is presently having the following sanctioned posts and actual strength:-

Professor	- 1	- Occupied by Prof. (Mrs.) C.R. Marak on regular basis
Readers	- 2	- Vacant
Lecturers	- 2	- Filled up.

The Head of Department has expressed her desire for furthering the cause of academic life and programme of the Department and for this purpose had recommended the name of Prof. S.N. Goswami who had retired as Professor from Gauhati University on July 1999, His last pay drawn in the pre-revised pay scales in Rs.6500/- in terms of Cl.2 of RE-3, the Executive Council had the power to make contract appointment against floating post in the teaching cadre of Professor, Readers and Lecturers.

However, the Executive Council vide resolution No.EC:103:99:5:1:(iii) at Annexure 'A' has resolved that the section I on General recommendation is to be taken up in the next A.C. which includes that the pay of visiting Professor/Professor on Contract should be suitably revised in the light of the New pay Scale. Pending the decision for implementation of the revised New pay, the proposal to appoint Prof.S.N.Goswami under Cl.2 of RE-3 against a floating post in the revised pay scale would not be possible at this stage. It is therefore proposed that the appointment of Prof. Goswami would be for an initial period of one year and if approved, be allowed to draw in the minimum of the pre-revised pay scale of Rs.4500-7300/- and once the revised pay is accepted for implementation his pay may be fixed accordingly under re-employment basis.

The proposal of the Pro Vice-Chancellor Tura and Head of Department Garo, under annexure B, and C, is therefore placed before the Council for consideration.

The Council further RESOLVED that (1) clarification be sought from MHRD/UGC on the cases of those Group 'A' Officers, like Engineers and Medical Officers who are not treated as teachers or other academic staff.

- (2) Clarification also be sought from UGC/MHRD about the qualifications of Principals.
- (3) Comprehensive amendment, including the existing points and those proposed for amendment be made before being sent to MHRD.

Sir,

I request you to kindly appoint Prof.S.N.Goswami to the Deptt. of Garo under the provision of NEHU Regulations RE-3 on contract Appointments to Academic posts (under Ordinance OE-5) sections 2,3,4,5,6,7, The said Professor at present occupies the post of Rabindranath Tagore Professor in the Deptt. of Modern Indian Languages, Gauhati University, and is due to retire in July 1999 at the age of 62. He was Head of the Department of Assamese in Dibrugarh University since his joining in 1967 till 1974. During his headship he introduced Deploma Course in Tai- Ahom Language under the Deptt. of Assamese in 1972 in D.U. He introduced M.Phil. Course in Assamese in the Department of Modern Indian Languages, Gauhati University in 1985. He was also responsible for the introduction of Certificate Course in Boro in 1988, Diploma Course in Boro in 1990 and Post-Graduate Course in Boro in 1995 under the Department of Modern Indian Language, G.U. while he was holding the headship of the Department.

Justification : Prof.S.N.Goswami is a suitable candidate to meet the requirements of the Deptt. of Garo, because he holds M.A. degree in comparative Philology and Linguistics from calcutta University (1959). As an experienced Professor, he will be a great help particularly in creating research atmosphere as under his guidance in Debrugarh University and Gauhati University 27 scholars have been awarded Ph.D. degrees and many of them on tribal languages of Assam, Meghalaya and Arunachal Pradesh.

At present, for a period of one month he is teaching the theory section of Course XIV Garo Folklore as Visiting Fellow, approved by Dy.Registrar(Acad.)'s letter No.G.15-8/Acad/V.P/Garo/97-3471 dated 13.11.93. The 4th semester students are greatly benefitted by his lectures.

Prof. Goswami contributed substantially to the success of the National Seminar on Garo Language and Literature organised by this Department on 7-8 May '99 at Tura NEHU, Campus. As he teaches Literature, Linguistics, Folklore, scholars consulted him in writing seminar papers. During his brief stay since 19th April '99 to the present he has contributed to the academic life of the Campus.

Hence, I request you to kindly consider his contract appointment sympathetically for furthering the cause of academic life and programme for **this** Department and to the Tura NEHU, Campus in general.
