

(iv) Technical resignation tendered by Dr.
S. Jawaid as Reader in Public Admn., M.C.

The Executive Council in its resolution No. EC:98:98:3:(iii) adopted on 15.9.98, considered the grant of lien to Dr.S.Jawaid for a period of one year w.e.f. 1.8.98 to enable him to join his assignment as Reader in Political Science at Aligarh Muslim University. The application of which was duly forwarded by NEHU.

On completion of ~~the~~ one year lien Dr.S.Jawaid in his letter dt. 15.7.99 tendered his technical resignation from the post of Reader, Deptt. of Public Administration, Mizoram Campus stating that he has been confirmed as Reader at A.M.U., w.e.f. 1.8.99, vide order at ANNEX-URE-I.

In this connection, no dues certificates have been called from all the concerned sections and replies have been received from all the sections stating that nothing is outstanding against him in the University. Further, Dr.S.Jawaid has also remitted the Leave Salary/Pension Contribution for the lien period w.e.f. 1.8.98 to 31.7.99 to NEHU in his letter dt.28.11.2000.

In view of above, the technical resignation submitted by him has been accepted by Vice-Chancellor, w.e.f. 1.8.99. The matter is therefore reported to the E.C. for ratification, and that the Council may perhaps approved the transfer of his service from NEHU to AMU as requested by him which is admissible as per rules.
