3. After joining the Institute, you will be required to submit a bond for serving the Institute for a minimum period of two years failing which you will be required to pay a compensation of Rs. One lakh to the Institute.

4. The Institute has a system of continuous evaluation of performance of every faculty member and unsatisfactory performance may entail denial of increments in salary or termination of employment.

5. You will be governed by the Contributory Provident Fund Scheme of the Institute as framed/amended from time to time. You will also be eligible for reimbursement of medical expenses incurred for self and family as per the Scheme of the Institute.



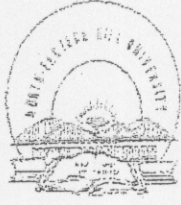
