- i) Technical resignation w.e.f. 31.01.1991 tendered by Dr.B.K.Ratha, Professor of Zoology NEHU on his new assignment at BHU- a ratification thereon.

Dr.B.K.Ratha was appointed as Lecturer in Zoology, NEHU, Shillong on 30.4.1977 and subsequently appointed as Reader and Professor w.e.f. 16.8.1982 & 15.11.1988 respectively.
