Shri V.K. Nath was appointed as Lecturer in the Department of Electronics and Communication of this University w.e.f. 24.07.2006 and was placed under probation for a period of two years. Shri. V.K. Nath, due to unavoidable personal reasons, expressed his inability to continue in the services of the University and as such has submitted his letter of resignation and requested the University to relieve him from the services of the University w.e.f. 30.11.2007. The letter dated 17.09.2007 received from Shri. V.K. Nath along with the endorsement of the Head of the Department may kindly be seen at Annexure – 1.

In terms of provisions as laid down under OE-5 vide Clause-11

“A teacher, may, at any time, terminate his engagement by giving the Executive Council three months notice in writing. Provided that the Executive Council may waive the requirement of notice at its discretion. Provided further that if the notice period ends in the middle of academic semester and the leaving of the teacher is likely to affect the teaching work, a teacher may be released only at the end of the semester in the case of the University teacher and at the end of academic session in the case of the constituent Colleges”.

In the instant case, there is a shortfall in the notice period and as such, the Council may like to condone the requirement of the notice period and accept the resignation of Shri. V.K. Nath w.e.f. 30.11.2007 (AN) subject to clearance of dues, if any, outstanding against Shri. V.K. Nath.

The matter is, therefore, placed before the Council for consideration.

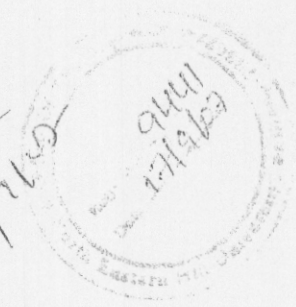
