

- (xii) Extension of deputation term in r/o Shri Atul Dev Sarmah, Assistant Editor, NEHU, Publication Shillong.

Shri Atul Dev Sarman, Assistant Editor, NEHU, Publication Shillong was allowed to go on deputation and his services was placed at the disposal of the Director of Adult Education, Ministry of Human Resource, Development Deptt., Department of Education, Govt. of India, New Delhi on foreign service terms as Deputy Director (Publication) w.e.f. 15.8.93 to 24.8.96 i.e. 3 (three) years vide EC Resolution No. EC:79:93:6:02 in its 79th meeting held on 20.7.93.

The Deputy Field Adviser Govt of India, Directorate of Adult Education MHRD vide his letter dated 5.8.96 (Annexure-A) request to extend the service of Shri. Atul Dev Sarmah for another period of one year. The office has examined the case and further extension was regretted and Shri. Atul Dev Sarmah was requested to join the University on expiry of the deputation period.

However, the Deputy Field Adviser vide letter dated 24.8.96 (Annexure B) stated that the Directorate of Adult Education is willing to absorb Shri. Atul Dev Sarmah and action in this regard has already been initiated by the Ministry with the Deptt. of Personnel and on this ground the Deputy Field Adviser to extend the deputation period of 1 (one) more year w.e.f. 31.8.96.

The vice-chancellor has therefore extended the service of Shri. Atul Dev Sarmah for another period of 1 year with effect from 25.8.96 and not from 31.8.96 requested by the Deputy Field Adviser as per order at (Annexure -C).

The matter is therefore placed before the E.C. for ratification.
