

(v) Grant of Lien to Dr. R.P. Kachhara, Reader in Geology.

Dr. R.P. Kachhara, Reader, has requested for grant of lien for one year to enable him to join as Professor at Nagaland University, as the application to the post applied for by him was duly forwarded by NEHU.

Dr. Kachhara being a confirmed employee has served the University for a continuous period of 10 years - 6 months, w.e.f. 14.10.85. As per rule, grant of lien is permissible to a confirmed permanent employee. The Vice-Chancellor, therefore approved the grant of lien for one year and the Pro-Vice-Chancellor, Mizoram Campus released him w.e.f. 17.5.96 F.N. to join Nagaland University, with a condition that the leave salary and pension contribution shall have to be borne and paid to NEHU by Dr. R.P.Kachhara if the Nagaland does not pay.

Before the expiry of the lien period of one year ie. on 16.5.97, the Deputy Registrar, Mizoram Campus, forwarded the application of Dr. Kachhara dt. 8.4.97 requesting for extension of lien for a further period of one year w.e.f. 17.5.97.

Under the normal rules, grant of lien is for a period of 2 years only. The Vice-Chancellor approved the extension for another period of one year w.e.f. 17.5.97 indicating that he should either revert to the parent deptt., within that period or resign at the end of the period.

The matter is therefore, placed before the Executive Council for ratification of the action taken in granting lien to Dr. R.P. Kachhara w.e.f. 17.5.96 to 16.5.98 for a period of 2(Two) years.
