

- (iv) Appointment of Prof. B.Pakem as Vice-Chancellor, NEHU, for a term of 5 (five) years.

Prof. B.Pakem have been released from the post of Professor, Political Science Department, NEHU to join as Vice-Chancellor, NEHU for the first term of 5 (five) years w.e.f. 21.12.91 (AN) with grant of lien for five years in Political Science Department; vide EC resolution No.EC:74:92:03:(vii) Extract of the minutes is placed as Annexure 'A'.

Subsequently, on the expiry of five years on 22.12.96; the University has issued a notification No.F.14-12/Estt.II/Vol.I-4314, dated 9.1.97 (vide Annexure 'B') read with Statute 2 (a) (2) of the NEHU Act, 1973, notifying his continuation in the office of the Vice-Chancellor, NEHU, until further orders. This is in accordance with MHRD's letter No.8-24/96-Desk (U)(Pt) dated 30.12.96 (Annexure 'C').

Finally, vide MHRD's letter No.8-24/96 Desk(U) dated 13th January, '97 (Annexure 'D') Prof. B.Pakem has been appointed by the Visitor as Vice-Chancellor, NEHU for 5 (five) years. Accordingly Prof. Pakem assumed charge for the Vice-Chancellor post w.e.f.18th January, 1997 (AN) (Vide Annexure 'E').

In the above context, it may be stated for the information of the Council that :-

1. Prof. B.Pakem is due for his Superannuation on 31st December, 1997 as Professor in Political Science Department.
2. Prof. B.Pakem had also applied for re-employment in the political science Department for a term of two years for which a separate agenda had been placed to the E.C. to this effect.

Consequent upon his superannuation date of 31st Dec'97, stated above, the Council is thus moved to allow him to retain the lien for the Professor post in Political Science Department till 31st Dec'97 until he retires on that day in continuation of resolution Annexure 'A'.

Further in point of information No.(2) above the issue of re-employment in Political Science Department after 31st Dec'1997 (Date of Superannuation) has now been intervened by his appointment as the Vice-Chancellor for a term of 5 (five) years w.e.f. 18.1.97 or till he attains the age of 65 years whichever is earlier.

Therefore, the issues of retaining lien as Professor Political Science Department till 31st Dec'97 and the re-employment for 2 years after superannuation are placed to the Council for decision.

The Council RESOLVED to ratify the action taken by the Acting Vice-Chancellor in releasing Prof. B. Pakem from the post of Professor with effect from 21.12.91 (AN). It further RESOLVED that Prof. Pakem will retain lien during his tenure as Vice-Chancellor.

No: EC: 92: 97: 6: 2: (vi): The Council considered the upgradation of pay-scale in respect of the Medical Officers/Senior Medical Officers of the University and RESOLVED that the Senior Medical Officers in the pay-scale of Rs. 3000-4500/- may be upgraded to Senior Medical Officer Grade I in the scale of Rs. 3700-5000/- on completion of 12 years of service out of which atleast 5 years must be as Senior Medical Officer Grade II in the scale of Rs. 3000-4500. The Council, further RESOLVED that as regards the conversion of posts to that of Chief Medical Officer the same may be done on a specific approval from the University Grants Commission.
