

- (iii) Change of effective date in respect of teachers placed in Sr.Scale/Selection Grade/Reader under C.A.S. after 1.1.96.

The UGC vide its notification dt. 24.12.98, has revised the guidelines for placement of Lecturer in Sr.Scale/Selection grade Reader/Professor under C.A.S. w.e.f. 1.1.96. In this connection, there are a number of candidates, whose cases have been processed as per old guidelines, and their cases were duly recommended by the Selection Committees and approved by the E.C. respectively. Now the teachers desire that since their cases have been cleared by Selection Committee and E.C. Their effective date for placement/Promotion be made effective from 1.1.96.

This matter was placed before the E.C. in its 106th meetings held on 13.4.2000. However the E.C. vide its resolution No.EC:106:2000:6:1: dt. 13/4/2000 resolved that such teachers desiring placement/ under the time frame stipulated under the V Pay package may apply for consideration under the new rules".

In this connection the NEHUTA had submitted a representation stating that lecturers who have completed the requisite number of years for this promotion before 1.1.96, but promoted after 1.1.96 to Sr. Scale/Selection grade/Reader, the effective date of promotion for these lecturers should be notified as 1.1.96, since their cases have already been cleared by Selection Committees and E.C. respectively and need not be processed again as decided by E.C. vide resolution No. EC:106:2000:6:1. dt. 13.4.2000.

The matter is therefore, placed before the Council for decision and approval.
