

(vi) Grant of lien to Dr. B.S. Butola, Reader in Geography department.

Dr. B.S. Butola, Reader, Department of Geography, joined the University w.e.f. June 13, 1985, is a confirmed teacher and has been serving the University continuously for a period of thirteen years. In his letter dated 1.9.98, he has informed that he has been offered the post of Associate Professor in the Centre for the Study of Regional Development, School of Social Sciences, Jawaharlal Nehru University, Delhi, and has requested to release him to join a new assignment on EOL on lien for a period of two years, effective from 1.12.98.

In this connection, the application submitted by Dr. Butola for the above post was duly forwarded through proper channel vide letter dated 25.8.97, and the post offered is an equivalent post in the scale of Rs. 3700-125-4950-150-5700/-. Being a confirmed teacher of NEHU and that his application for grant of lien is duly forwarded and recommended by the Head of Deptt., and as per decision of the Executive Council at its 93rd meeting held on 5.8.91 which Resolved the grant of lien to NEHU teachers, the request to be released on lien for a period of two years w.e.f. 1.12.98 may be considered subject to furnishing of the required Undertaking to Para (2) of the G.O.I. OM No. 60/37/03/Estt-(A) dated 14.7.67 of F.R. 13 and clearance of no outstanding dues to be received from the various deptts.
