

- (xi) Deputation to Nagaland University in respect of Dr.S. Changkija, Scientific Officer, RSIC.

Dr.Sapu Changkija ,Scientific Officer,RSIC,NEHU has applied for deputation to Nagaland University which was duly forwarded by the Head,RSIC for the post of Reader in Botany Department.

The Nagaland University has issued an appointment Order dated 17.3.98 in respect of Dr. Changkija,Scientific Officer, RSIC as Reader on usual deputation terms initially for a period of 1(one) year (Annexure-I).

The case was accordingly taken up in its 97th Executive Council for consideration of his release on deputation. However, vide resolution No:97:98:6:3:(v), the Executive Council considered the release of Dr. Changkija, Scientific Officer on 'Lien' for a period of 1 year instead of 'Deputation!'. With the approval of the Vice-Chancellor, Dr. S. Changkija was released on deputation subject to ratification of the term 'Lien' to 'Deputation' so as to enable Dr.S. Changkija to join his post as Reader in Nagaland University, Medziphema, Nagaland.

The matter is placed before the Executive Council for ratification.

1. The appointment will be on transfer on deputation on foreign service initially for a period of one year.
2. During the period of foreign service, the employee will have the option to draw his own grade pay plus deputation (duty) allowance or to have his pay fixed in the scale of pay of the post in Foreign Service.
3. Joining time pay and transfer T.A will be borne by the Nagaland University (BORROWING DEPARTMENT)
4. T.A. for journey on duty will be as per rules of the Nagaland University (Borrowing Department) and expenditure would be borne by Nagaland University.
5. Leave salary and pension contribution (or CPF contributions as the case may be) at the prescribed rate, would be payable by the Nagaland University (Borrowing Department) to North-Eastern Hill University.
6. In case it is desired by the Borrowing Department, Nagaland University to absorb the employee permanently, prior consent of North-Eastern Hill University will have to be obtained. In case the permanent absorption is made without obtaining prior consent of the North-Eastern Hill University, the Borrowing Department, Nagaland University will be liable to pay all the dues which may be payable by the employee to North-Eastern Hill University either from its own source or by recovering the same from the employee.
7. During the period of foreign service the employee will continue to subscribe to GPF/CPF of the North-Eastern Hill University and regularly remit the usual subscription to the Finance Officer, NEHU, Shillong.
8. D.A and other allowances shall be allowed at the following rate:-
 - a) at the rate admissible to his scale of pay if he opts for the scale of pay under the North-Eastern Hill University

or b) at the rate admissible to the scale of pay attached to the post if the deputationist opts for the scale of pay of Nagaland University.

9. While on deputation, he will be allowed to avail himself of the medical facilities prevalent under the foreign employer. If the medical concession prevalent under the foreign employer are less attractive than the concession available under the North-Eastern Hill University, he will have option for himself to get the benefits available under the North-Eastern Hill University.
10. He shall be allowed to avail himself of the leave Travel Concession available to him in the North-Eastern Hill University or as allowed by the Nagaland University whichever is advantageous.
11. Other conditions of service will be governed by relevant rules and order applicable to members of foreign service in force from time to time.
