Dear Madam,

With respect to the above, I am given to understand that further clarification is sought on the matter from your office. May I submit the same below.

Dr. Basu Baul applied for the BOYSCAST Fellowship through proper channel (vide your letter No. F.1-19/SCH/92-1007 dated 26.5.1994). After being awarded the Fellowship Dr. Basu Baul applied for leave w.e.f. January, 1995 for one year (vide letter No. RSIC/SHG/BOYSCAST/PF-1856 dated 10 November 1994). When this was not immediately forthcoming, the Department of Science & Technology, Govt. of India also wrote to the Vice-chancellor and to the Registrar, NEHU to release Dr. Basu Baul accordingly as per NEHU's commitment in the application form (D.S. letter No. SR/BY/C-01/94 dated 20th January, 1995).

Dr. Basu Baul then applied to the head, RSIC to release him so as to join the Australian Institution by 26th March, 1995 the committed date of joining by that institution or else the Fellowship might be forfeited.

Since the leave matter was a committed one by NEHU and the formal sanction was being awaited the HOD, RSIC permitted Dr. Basu Baul to leave accordingly. The formal NEHU sanction came only in September 1995 (vide order No. F.1-19/SCH/92-2438 dated 14.9.1995).
