

- (xxi) Extension of Deputation term in respect of Shri Atul Dev Sarmah, Assistant Editor, NEHU, Publication, Shillong.

Shri Atul Dev Sarmah, Assistant Editor, NEHU, Publication, Shillong was allowed to proceed on deputation for a period of 3 (three) years on foreign service terms as Deputy Director(Publications) in the Directorate of Adult Education, New Delhi with effect from 25-8-93 to 24-8-96 vide 79th Executive Council resolution No:EC:79:93:6:02(viii).

Subsequently, the term of deputation was extended for another period of 1 (one) year with effect from 25-8-96 to 24-8-97 vide 91st Executive Council resolution No:91:96:3:(xii).

The Director General & Joint Secretary, Adult Education vide letter D.O. No.F.14-6/93-D. III(A & E) dated 5.05.97 (Annexure 'A') requested for extension of the services of Shri Atul Dev Sarmah for another period of 1 (one) year.

The Office has examined the matter and the Vice-Chancellor has approved the extension for the 5th year i.e., with effect from 25-8-97 with no further extension be considered to Shri Atul Dev Sarmah beyond the fifth year of deputation.
