

vii) Confirmation in respect of Group-A category non-teaching posts and that of the senior scale of Sri K.Nengnong, Asstt. Registrar.

The constituted D.P.C for Group-A category, non-teaching posts under Notification No.F.14-131/Estt.II/90-1017 dt. 1.9.99 at Annexure-I met on 19.11.99 in the Registrar's chamber to consider the confirmation of Sri P.P.Dey, Senior System Analyst, Sri S.Ghose, System Analyst, Miss B.Rynjah, System Analyst, Sri L.M.K.Lyngrah, Deputy Registrar, and Sri J.N.Nayak, Deputy Registrar, Tura Campus. The D.P.C also considered the case of Sri K.Nengnong, Asstt. Registrar for placement in the senior scale in view of E.C meeting held on 16.3.99 vide resolution No.EC:100:99:6:6:(iii) considered the placement in the senior scale in respect of Sri K.Nengnong and resolved that the shortage of days of training may be met by another training period and the matter be placed before the D.P.C before consideration by the Council. This is at Annexure-B.

1. Sri P.P.Dey was appointed to the post of Senior System Analyst, Computer Centre, w.e.f 21.8.93 on the recommendation of the Selection Committee and in pursuance of the E.C in its meeting held on 20th July, 93 and was on probation for a period of one year. He has completed the probationary period and the D.P.C considered his case for confirmation after verification of character and antecedent from the Deputy Commissioner and there was no adverse report against him. The D.P.C recommended that, he may be confirmed against the post of Senior System Analyst from the date of joining i.e 21.8.93 and to be accommodated against the sanctioned post vide D.O. No.F.P1-1/87(T II) dt. 3rd January, 90.

2. Sri S.Ghose was appointed to the post of System Analyst, Computer Centre w.e.f 2.11.91 on the recommendation of the Selection Committee and was on probation for a period of two years in pursuance of the E.C resolution No.EC:72:91:6:01:(i) in the E.C meeting held on 26.9.91. The Committee examined the character and antecedent received from the Deputy Commissioner and there is no adverse report against him and recommended that Sri S.Ghose, System Analyst may be confirmed against the post of System Analyst from the date of joining the University and be accommodated against the sanctioned post vide D.O.No.F.P1-1/87(T II) dt. 3rd January, 90.

3. Miss B.Rynjah was appointed as System Analyst, Computer Centre on the recommendation of the Selection Committee and in pursuance of the E.C resolution No.EC:72:91:01:(i) in its meeting held on 29.6.91 from 27.9.91 and was placed on probation for a period of two years. The Committee examined her A.C.Rs and character and antecedent received from the Deputy Commissioner and there is no adverse report against her. The Committee recommended that Miss B.Rynjah may be confirmed against the post of System Analyst from the date of joining i.e 27.9.91 and accommodated against the sanctioned post vide D.O. No.F.P1-1/87(TII) dated 3.1.90.

4. Sri L.M.K.Lyngrah, was appointed to the post of Deputy Registrar on the recommendation of the Selection Committee, which was ratified by the 91st E.C vide resolution No.EC:91:96:3:xxi held on 7.12.96 and was placed on probation for a period of one year w.e.f 23.10.96(FN). The Committee examined the A.C.Rs, character and antecedent received from the Deputy Commissioner and there is no adverse report against him. The Committee recommended that Sri L.M.K.Lyngrah may be confirmed against the post of Deputy Registrar from the date of joining the University and be accommodated against one of the posts created under the 8th Plan period.

5. Sri J.N.Nayak was appointed to the post of Deputy Registrar on the recommendation of the Selection Committee and ratified by the E.C in its 91st meeting held on 7.12.96 vide resolution No.EC:91:96:3:xxi w.e.f 10th December,96 and was placed on probation for a period of one year. The Committee examined the A.C.Rs of Sri J.N.Nayak and that of his character and antecedent, received from the Additional Deputy Magistrate, Sambalpur and there is no adverse report against him. The Committee recommended that Sri J.N.Nayak, Deputy Registrar may be confirmed to the post of Deputy Registrar from the date of joining i.e 10th December,96 and be accommodated against the sanctioned post of Deputy Registrar under the Jungjappa Committee.

6. The E.C in its meeting held on 16.3.99 vide resolution No.EC:100:99:6:6:iii considered the placement in the senior scale in respect of Sri K.Nengnong and resolved that the shortage of days of training may be met by another training period and the matter be placed before the D.P.C before consideration by the E.C. The office deputed Sri K.Nengnong to attend a training programme on "Decentralised Planning" in Guwahati from 2-6 August, 99, organised by the National Institute of Rural Development,

North Eastern Regional Centre. Sri K.Nengnong participated in the following training programmes.

As Asstt. Registrar, Sri K.Nengnong has attended four training programme at Jamia Millia Islamia and at Guwahati for a period of 46 days but if the In-service training programme conducted by the Institute of Secretariat Training and Management, New Delhi attended by him as Section Officer is taken into account for the period of 12 days, the total No. of days is 58 days.

As per the requirement under the U.G.C's letter dated 2nd February,94, he has to attend four training programmes of two weeks duration to become eligible to be placed in the Senior Scale. The Committee also examined the A.C.Rs and there is no adverse report against him. The matter is placed to the E.C for consideration for confirmation of all the officers of the Computer Centre, Deputy Registrars and also for placement of Sri K.Nengnong in the Senior Scale.
