Dr. V.B. Singh, Reader Horticulture,
SASRD, Nagaland University.

Dr. V.B. Singh, Reader Horticulture, SASRD, Nagaland University has opted for NEHU services and subsequently was released on lien for a period of two years to join the post of Professor in Nagaland University with effect from 5.7.96 (AN) The lien was extended for another period of one year from 5.7.98 to 4.7.99 on condition that Dr. Singh should submit an undertaking that on the event of the expiry of the extended period he should either revert to the parent department or resign from the department at the end of the extended lien period.

The Vice-Chancellor Nagaland University vide his letter at Annexure 'A' has requested NEHU to extend his lien period for another period of two years, and if this is not possible he may be allowed to be on deputation for two years. Earlier the Deputy Registrar Nagaland University in his letter placed at Annexure 'B' had intimated that Nagaland University is contemplating to absorb Dr. Singh during the extended period of third year of his service on lien subject to his willingness, but the Nagaland University could not keep their commitment, as Dr. Singh has expressed his unwillingness to be absorbed in Nagaland University vide letter dt. 2.4.99 Annexure 'C'. Further, the service of Dr. Singh presently placed on lien with Nagaland University, not covered by the term and condition of deputation, the case therefore if further considered for placement of his service on deputation in continuation to the three years lien earlier already granted would be in violation against the provisions laid under Lien/Deputation.

The matter is therefore placed before the Executive Council for consideration and decision.
