

- (vi) Extension of deputation of Prof. M. Miri to I I A S, Shimla.

Prof. M. Miri of Philosophy Deptt. is at present on deputation to I I A S, Shimla for a period of three years w.e.f. 11-9-93 (F.N.) as approved by the E.C. at its 80th meeting vide Resolution No: EC:80:93:03: (xii) held on 6-12-93. His three years term expires on September 11, 1996 and has requested for extension of the same vide his letter dated 4-9-96 at Annexure A & B.

Shri S. Gopal, the Chairman, Governing Body, I I A S, Shimla, has sent a letter dated 16-11-96 placed at Annexure C stating that Prof. Miri's first three year term ended and he is eligible for the second term as Director. Final decision for renewal of his appointment as Director is under active consideration of the G.O.I. He has therefore, requested for extension of the deputation term from 11-9-96 for one interim period.

As per GOI Order Appendix 5-8-3 the maximum period of deputation is 5 years. Since the first term of Prof. M. Miri is for a period of three years only, i.e. 11-9-93 to 10-9-96, the request for extension of deputation of the Chairman Governing Body, I I A S, Shimla in respect of Prof. M. Miri may be considered only for another period of two years only i.e. 11-9-96 to 10-9-98 in addition to three years which has already been approved. (Extract relevant is placed as Annexure "C")
