

- (iii). Grant of Sabbatical leave in respect of Dr. M.K. Parida, Reader in Physics Deptt. wef: July, 1998 to June, 1999.

Dr. M.K. Parida, Reader in Physics Department joined in NEHU, Shillong on 14-9-1985 and is confirmed in the post. He submitted an application dated 30/5/98 requesting for grant of 1(one) year Sabbatical leave wef: July '98 to June '99 for Study & Research in High Energy Physics at University of Wuppertol, Germany and Theoretical physics at Italy besides, study and research in High Energy Physics in India.

The application had been submitted through Head, Department of Physics with the recommendation of the Dean, School of Physical Sciences for consideration of the requested Sabbatical Leave to Dr. M.K. Parida. Having examined the case, Dr. Parida was found to fulfill the conditions as laid down under Cl-11 of ordinance OE-6 and also not having availed any Study Leave/EOL/Sabbatical Leave during his service period in N.E.H.U. the Vice-Chancellor NEHU, Shillong granted 1 year Sabbatical leave w.e.f. the date of handing over the charge to the HOD concerned. The required Bond against the Sabbatical leave for 1(one) year has been executed by Dr. Parida and since accepted by the University and sanction order dated 10/7/98 issued subject to ratification of the Executive Council.
