(viii) Extension of deputation pe riod from 1.7.96 to 31.1.97 in respect of Dr. O.P. Singh, Lecturer, SASRD.

Dr. O.P. Singh joined as lecturer on 8.10.85 in the department of Zoology in SASRD, Medziphema, and on the existence of Nagaland University he opted for NEHU but was on deputation with Nagaland University upto 30.6.96 Annexure A. Dr. O.P. Singh was sanction sabbatical leave for a period of one year by the Registrar Nagaland University vide order dt. 29.8.95 at annexure B.

The Deputy Registrar Nagaland University vide his letter dt. 5.7.96 at annexure C has stated that Dr. O.P. Singh was on sabbatical leave for a period of one year i.e. from 1.9.95 to 31.8.96 but his deputation in Nagaland University been expired on 30.6.96 and as such has requested to consider the extension upto 31.12.96.

The Dean School of Agricultural and Rural Development in his letter dt. 29.5.97 vide annexure D has informed that Dr. O.P. Singh returned from leave on 10.1.97 and his salary has been paid upto 31.1.97. Therefore to cover up the period already spent in Nagaland University and full salary paid upto 31.1.97 he has requested to convey our approval for extension of the deputation period upto 31.1.97 in the interest of the Institution.

In view of the position of the case and in order to regularise the period of deputation from 1.7.96 to 31.1.97 as the deputation period expired on 30.6.96 the Vice-Chancellor NEHU, has accepted the request of Nagaland University for extension of his deputation upto 31.1.97 in respect of Dr. O.P. Singh, and the Dean SASRD, Nagaland University has been informed vide letter No.F.19-196/Estt-II/85-36 dt. 14.5.98 at annexure E.

The matter is therefore placed before the Council for favour of ratification of the action taken by the Vice-Chancellor.
