

- (1) Lien case in respect of Dr.P.K.Bajpai,
Lecturer, Department of Physics.

The Executive Council vide resolution No. EC:92:97:3:(viii) approved the grant of lien to Dr.P.K. Bajpai for a period of two years to enable him to take up an assignment as Reader at the Guru Ghasidas University, Bilaspur. He was then released from NEHU w.e.f. 1.11.96. On the expiry of the two years lien i.e. 31.10.98, Dr.P.K. Bajpai did not report to NEHU. Two letters were issued to him dated 12.5.99 and dated 22.7.99, requesting him to resume duty immediately, but vide his letter dated 2.8.99(Annexure-I) requested for extension of lien for another period of one year as his confirmation at Guru Ghasidas University has not been notified. Comments of the Head of Department was sought in which he has not recommended for extension but has informed that Dr.P.K. Bajpai should be asked to join duty immediately(Annexure-II).

In this connection, a letter dated 16.3.2000 was issued to him and sent by SPEED-POST directing him to revert to NEHU immediately, but Dr.P.K.Bajpai did not comply with the office letters as he is keeping silent till date. The Executive Council in the meeting held on 13.7.2000 while deciding the case of Dr.P.N.Ram resolved that [Ref. Resolution No.EC:107:2000:6:3:(i)] he should be asked to resume duties by issuing a Registered A/D letter, in case he fails to resume duties, it should be treated as the post being vacated by Dr.Ram. In the same resolution, the Executive Council decided that similar cases be placed before the E.C.

The case of Dr.P.K. Bajpai is similar to that of Dr.P.N.Ram. Dr.Bajpai has been asked to resume duties but he has not complied with the direction. Moreover, in the case of Dr.Bajpai, the Head of the Department desires that this post should not be kept vacant further and should be filled up urgently.

The matter is placed before the Council for consideration.
