

- (iii) Re-appointment of Visiting Fellows in the Centre for Cultural and Creative Studies.

There are 2 posts of Reader and 1 post of Lecturer (reserved for Physically handicapped) lying vacant in the Centre for Cultural and Creative Studies for quite some time. Efforts were also made by the University to fill up these posts through advertisement, but due to lack of qualified candidates, the said posts could not be filled till date.

However, to run the courses in the Centre, the Visiting Fellows viz., Shri Bedanta Kalita and Shri B.Hynniewta were appointed in the Centre. On expiry of their term of appointment, the Head of the Centre vide his letter at ANNEXURE 'A' requested the University to consider re-appointment of Shri Kalita and Shri Hynniewta as Visiting Fellows for the academic session from 1st August 2006.

Considering the need of the Centre, the Vice Chancellor, subject to the ratification by the E.C. has approved the re-appointment of Shri Bedanta Kalita and Shri Benedict Hynniewta as Visiting Fellows w.e.f. 1.8.2006 to 15.12.2006 or date of appointment of regular incumbent whichever is earlier, and they were placed at the minimum of pay scale of Rs.8000-275-13,500/- plus other allowances.

The action taken by the Vice Chancellor is, therefore, placed before the Council for ratification.

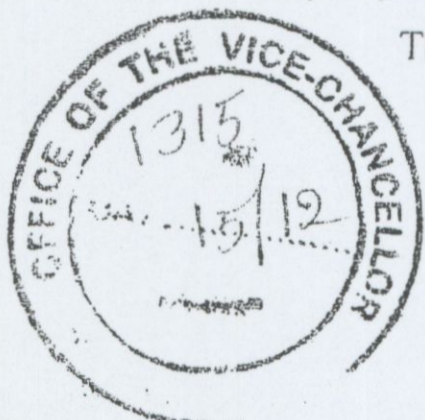




