

Dr. B. B. C. Sangma(v) Appointment of Pro-Vice Chancellor, NEHU

Consequent upon the appointment of Prof. B. Pakem as Vice Chancellor, NEHU, for a period of five years and in continuation of notification No. F.4-12/Estt.II/Vol.I-4314 dated Jan. 9, 1997, and as per Statute 3(2) of NEHU Act, the Vice Chancellor is pleased to appoint Prof. K. Lalthantluanga and Prof. M. S. Sangma as Pro-Vice Chancellors, NEHU, for Mizoram and Tura campuses respectively for another period of five years subject to ^{whichever is earlier.} attaining of 65 years of age. Their appointment is co-terminous with that of the Vice Chancellor.

however, as per records available in the office, ^{Prof. M. S.} Sangma, PVC, Tura Campus, will attain the age of 65 years on 1.1.2001, as per Statute 3(2) the P.V.C shall retire on attaining the age of 65 years. Therefore, the appointment of Prof. M. S. Sangma as P.V.C, Tura Campus, will be upto Dec. 31, 2000. A copy of the Statute 3(2) is placed at Annexure-A and the corrigendum to earlier Notification placed at Annexure-B.

ANNEXURE-A

3.(2) The term of office of a Pro-Vice-Chancellor shall be such as may be decided by the Executive Council, but it shall not in any case exceed five years or until the expiration of the term or office of the Vice-Chancellor, whichever is earlier, and he shall be eligible for reappointment;

Provided that a Pro-Vice Chancellor shall retire on attaining the age of sixty-five years.

No: EC: 92: 97: 6: 2: (iii): The Council considered the appointment of Ms. R. Roy as Lecturer in English at Mizoram Campus and RESOLVED that a final offer of appointment may be issued to her under a Registered A/D cover and she may be allowed to reply/join latest by 15th of April, 1997 failing which the offer may be given to the next candidate in the list. The Council, further RESOLVED that the validity of the Selection Committee's recommendations may be extended by a period of six months.

- (iv) Appointment of Prof. B. Pakem as V.C., NEHU, for a term of 5 (five) years.

- (v) Appointment of Pro-Vice-Chancellors, NEHU.

No: EC: 92: 97: 6: 2: (v): The Council considered the appointment of Prof. R. Lalthantluanga and Prof. M. S. Sangma as Pro-Vice-Chancellors for Mizoram and Tura Campuses respectively and while approving the same RESOLVED that the term of office of Prof. M. S. Sangma shall be upto 31.12.2000 only.

- (vi) Creation of a post of Chief Medical Officer in NEHU.

No: EC: 92: 97: 6: 2: (vi): The Council considered the upgradation of pay-scale in respect of the Medical Officers/Senior Medical Officers of the University and RESOLVED that the Senior Medical Officers in the pay-scale of Rs. 3000-4500/- may be upgraded to Senior Medical Officer Grade I in the scale of Rs. 3700-5000/- on completion of 12 years of service out of which atleast 5 years must be as Senior Medical Officer Grade II in the scale of Rs. 3000-4500. The Council, further RESOLVED that as regards the conversion of posts to that of Chief Medical Officer the same may be done on a specific approval from the University Grants Commission.
