

- (xi) Consideration of creation of posts as 'Personal' in respect of the repatriated Group B,C & D employees of erstwhile Nagaland Campus.

Consequent upon the coming into existence of the Nagaland University, 73 employees belonging to Group B,C,& D of the erstwhile Nagaland Campus had opted for NEHU Service. So far 64 of them have repatriated and the rest are still on deputation with the Nagaland University. The list of staff who have repatriated is placed at Annexure 'A' for reference of the Council.

Earlier the University administration had submitted a proposal to the UGC for creation of departments and posts to absorb the repatriated employees. However, the reply of the UGC vide letter No. D.O.No.F.7-1/90(CU) dated 29.Oct.1996.(placed at Annexure 'B') is that (a) no new non-teaching posts be created till all these employees are absorbed against regular vacancies (b) their services be utilised wherever required and (c) Posts may be created as 'Personal' only if there is no existing vacancy to absorb them.

Such being the direction of the UCC, the office had worked out the adjustment of posts for the 64 repatriated employees. As can be seen in the statement at Annexure 'C' showing the adjustment of posts, the following are left without any vacancies for adjustment, hence creation of 'personal' posts is necessary:

Dear Prof.Pakem:

Please refer to your D.O. letter No,PL.4-1/Grant/95-2188 dated 23rd August, 1996, enclosing therewith a copy of your letter No. PL.4-1/Grant/95-2187 dated 23rd August, 1996, addressed to the Ministry of Human Resource Development, regarding starting of Department of Commerce, Linguistics and Geology. Due to financial constraints, we may need to find new departments only in the IXth plan. In the mean time, could the faculty members be adjusted in allied departments? With respect to the creation of posts, specifically for those who have retired, please see the last paragraph of this letter.

As regards your request for supporting staff, it would be seen from your letter No.F.2/BUG/UGC 1995/392 dated 9.8.1996, that 79 non-teaching staff have opted for NEHU services out of whom 68 have already joined from the Nagaland Campuses. The services of these employees may be utilised wherever required and no new non-teaching post may be created till all these employees are absorbed against regular post. This would also apply to the proposed Department of Hindi.

The issue relating to the creation of posts for the staff repatriated from Nagaland campuses, the post(s) may be created in your University "as personal" to them only if there is no existing vacancy. For posts which are personal to them, the said post would stand abolished, as and when they retired or leave the services of your university.

FEES : (1) For appearance in cases before the Principal Seat at Guwahati (Civil/Criminal/Writ Petition/ Appeals ) lumpsum amount of Rs.10,000/-or Rs.15,000/- per case, depending on the nature of each case, till the case is finally disposed of.
