Dr. K.C.Baral, Reader in English, NEHU, Shillong was granted lien for a period of 2(two) years w.e.f. 11.08.1999(AN) to enable him to join the post of Professor at CIEFL, Regional Centre, Shillong. The lien was further extended for a period of 1(one) year w.e.f. 11.08.2001 to 11.08.2002.

On expiry of his lien period, the Registrar, CIEFL vide ANNEXURE-'A' conveyed that Dr. Baral has been confirmed as "Approved Probationer" w.e.f. 12.08.2000. Accordingly, Dr.Baral has tendered his Technical Resignation from the post held by him in NEHU from 12.08.2000 and the same was accepted by the Executive Council at its 123rd meeting held on 14.12.2005. Accordingly, an administrative order was issued to Dr. Baral. A copy of the order is placed at ANNEXURE – B.

Subsequently, in order to transfer his service from NEHU to CIEFL, Dr. K.C.Baral was asked to remit leave salary/pension contribution for the period w.e.f. 12.08.1999 to 11.08.2000 consequent upon his absorption in CIEFL w.e.f.12..08.2000. Instead of remitting the leave salary/pension contribution to the University, Dr. Baral had taken up the matter with the CIEFL, Hyderabad to confirm his service in the Institute w.e.f. the date of his joining i.e. 12.08.1999. Dr. Baral has now forwarded a copy of the Office order issued by CIEFL confirming the service of Dr.K.C.Baral w.e.f. 12.08.1999(vide ANNEXURE-C).

In view of the above, the Council may like to review its earlier decision and accept the technical resignation of Dr. K.C.Baral w.e.f. 11.08.1999(AN) i.e. from the date of his release from the University (on lien).






