The Executive Council vide resolution No:EC:97:98:3:(V) held on 14.7.98 and EC:103:99:6:3:(ii) held on 25.6.99, had approved the grant of lien to Dr. Harish Chandra w.e.f.30.4.98 initially for 1(one) year and extended upto 30.4.2000 to enable him to join an assignment as Reader Department of Chemistry at Delhi University.
