

(ii) The Chairman apprised the Council about a representation received from one of the teachers of the University regarding the change of Supervisor in respect of her research scholar. The Council RESOLVED that as long a teacher is in the University irrespective as to which department he/She is being transferred that teacher will remain as the Supervisor of his/her students.

Any other Matters:

(i) The members of the Council moved a motion for the opening of a Campus at Jaintia Hills or taking over of a College in Jowai/Shillong.
