

Amendment of Clause 2(1) of Ordinance
OE-4 on Notification of Vacancies and
Preliminary Selection.

The Executive Council in its 84th meeting held on
8.12.94 vide resolution No:EC:84:94:6: 7:(iii) resolved
that as a measure of economy, advertisements for vacancies
in Academic Cadres be floated only in the Employment News
and in one of the Local news papers of the States under
the jurisdiction of NEHU.

In view of above, Clause 2(1) of Ordinance OE-4
on Notification of vacancies and Preliminary Selections
which reads as under, needs amendment.

Mode of
Advertisement

2.(1) All vacancies in academic cadres of
the University shall be advertised
in at least four all India papers,
one each from the eastern, northern,
western and southern region and at
least one regional paper each of
the constituent units of the
University.

Provided that if there are some academic
positions for which the candidates are
likely to be exclusively available in a
particular region or regions, advertisement
may be limited to the papers in that
region or regions, only after recording
the reasons for doing so in writing and
with prior approval of the Vice-Chancellor.

In this connection, the proposed amendment has been sent
to the Ministry for obtaining the approval of the Visitor. The
proposed amendment is at Annexure-'A'.

The matter is placed before the Council for ratification.

AMENDMENT OF CLAUSE 2(1) OF ORDINANCE OE-4 ON NOTIFICATION OF VACANCIES AND PRELIMINARY SELECTIONS
