

- (xxiv) Reconsideration of date to Technical Resignation tendered by Dr. Saket Bhusan.

Dr. Bhusan, joined this University as a Lecturer in the Department of Animal Sciences, under the School of Agricultural Sciences & Rural Development located at Mediziphema on 22.7.1989. Subsequently, with the establishment of Nagaland University Dr. Bhusan was transfereed and posted to the Department of Zoology under Pachhunga University College, Aizawl w.e.f. 13.6.1996. During the tenure of his service in North Eastern Hill University Dr. Bhusan had applied for a post of Sr. Scientist at National Research Centre on Mithun, (under ICAR), Nagaland and was selected for the post. Accordingly, Dr. Bhusan was released by the this University on 27.9.1999 (A/N) vide Annexure-A. Consequently, he was absorbed by the National Research Centre, ICAR. After having confirmed, Dr. Bhusan has submitted his technical resignation was placed before the Executive Council at its 125th meeting to consider his technical resignation w.e.f. 26.9.1999 and which was duly considered and approved by the Executive Council vide Resolution No:EC:125:2006:6:2:125(vi) (vide Annexure-B).

Now, in the process of transferring his service liabilities from NEHU to his present organization, it has been found that the technical resignation of Dr. Bhusan is required to be accepted w.e.f. 27.9.1999(AN) (i.e. from the date of his release from this University) instead 26.9.1999.

The matter is therefore placed before the Council to reconsider the date of technical resignation of Dr. Bhusan w.e.f. 27.9.1999(A/N) instead 26.9.1999.
