- (i) Matters endorsed by the Executive Council for Academic Council consideration.

The Executive Council in its 97th meeting vide Resolution EC:97:98:8:(iii) had decided that the following matters be taken up in the Academic Council.

1. Reservation of teaching posts for SC/ST candidates to be identified.
2. Deanship be limited to 60 years as Headship in the Department.
3. Centre for Applied Statistics to help needy and relevant Departments.

The matter was placed before the 58th meeting of the Academic Council held on 10th September, 1998 and the Council considered the matters referred to it by the Executive Council and RESOLVED as follows:

1. A Committee consisting of the following may identify the teaching posts for reservation for SC/ST candidates.

3. Prof. (Mrs) T.Ao	Member
4. Prof. N.Malla	Member
5. Deputy Registrar(Estt. II)	Convener.

The Committee will elect its own Chairman.

2. The term of the Deans will be limited up to the age of 60 years as in the case of the Heads of the Departments.
3. The Centre for Applied Statistics shall assist any department in teaching if required.

The matter is placed before the Council for consideration.
