- (i) Nomination of University representatives

AC:30:87:03(i): The Council RESOLVED to approve the action taken by the Vice-Chancellor in nominating Shri Thanchungnunga, Department of Economics, NEHU, Mizoram Campus and Mr C.Lakima, Department of Public Administration, NEHU, Mizoram Campus as NEHU representatives, in the Governing Body of Aizawl College, Aizawl for a period of three years with effect from 6th July, 1987.

- (ii) Nomination of University representatives

AC:30:87:03(ii): The Council RESOLVED to approve the action taken by the Vice-Chancellor in nominating Dr R.N.Prasad, Department of Public Administration, NEHU, Mizoram Campus and Shri John Sailo, Department of English, Pachhunga University College, Aizawl as University representatives in the Governing Body of Champhai College, Champhai for a term of two years with effect from 9th July, 1987.

- (iii) Re-scheduling of Examinations -

AC:30:87:03(iii): While the Chairman was reporting the decision of the Executive Council on a point of order, one of the members wanted the Chairman to allow discussion on a letter issued by the President, NEHUTA. This was followed up by a few more members. The Chairman informed the Council that he had received the said letter a day before - after office hours from NEHUTA which is not a member of Academic Council and meanwhile he received two more/letters from amongst the members of the Academic Council on a similar subject which needs locking into records of the past 14 years and hence he could not possibly allow discussion on the matter.

Some members chiefly Prof.M.N.Karna, Prof.K.K.Chatterjee and Prof. Lalhantlung kept on insisting that the Academic Council discuss the letter issued by the President of NEHUTA, and this was endorsed by Prof. J.B.Bhattacharjee. The Chairman gave the ruling in the context of the situation that this was not possible. But the members named above kept on vociferously demanding that the letter be discussed. Dr.M.N.Karna kept on shouting and would not take his seat even after repeatedly being told so by the Chairman. He asserted that it is his voice and that is the way he speaks and that is the way he should be understood. These persons insisted that if this is not discussed they would not allow the Agenda of the 30th Academic Council Meeting to be discussed. The Chairman made a last request to know if they wanted the Academic Council Meeting to proceed. The three persons continued to create noise and disorder and started getting up and the Chairman, because of pandemonium being sought to be created, declared the meeting closed at 2:30 p.m.

The Chairman thus ordered the dissolution of the meeting at 2:30 p.m.
