(iv) Curtailment of deputation period

Prof. M. Miri of Phylosophy Department was initially placed at the disposal of Indian Institute of Advanced Study, Shimla for appointment to Director on Deputation basis for a period of three years w.e.f.11.9.93 only approved the E.C vide resolution EC:80:93:03:(xii) Before the expiry of the three years term on 10.9.96, Dr. Miri vide letter No.PS/D/1996/5005 dt. 4.9.96 informed that the Government of India is considering renewal of his appointment as Director IIAS for another period of three years and accordingly requested the Univer-sity for extension of the deputation period aforesaid. The E.C. vide resolution No:EC:91:96:6:3(vi) considered the extension of deputation and resolved to approve the extension of deputation for a period of two years and further extension of one year may be referred to the Ministry of Human Resource Development(Deptt. of Education) vide letter D.O.No.F.8-9/97-Desk (U) of 17.2.98 furnished a copy of the Secretariat of appointment Committee of the Cabinet bearing No.4(6)EO/97(ACC) dt. 14.2.97 in which the Appointment Committee of the Cabinet has approve the appointment of Prof. M.Miri as Director of IIAS for a period of three years. The E.C also in its resolution No:EC:96:98:6:3(v) resolved to approve the further extension of 3 years as his appointment was cleared by the Cabinet Appointment Committee. Government of India.

However, Prof. M. Miri vide letter(annexure-I) has tentatively planned to return to NEHU on 1.8.99 before the expiry of the deputation period allowed upto 10.9.99 and requested the Vice-Chancellor for permission of his return on the above date.

The matter is therefore placed before the E.C for consideration and nessary order.
