AC:56:97:5:1:(viii): The Council considered the petition of Shri.G.G.Pariat for submission of his M.A. dissertation and RESOLVED to accept the decision of the Executive Council.

5: 6 - Establishment of new Departments/Centres/Courses.

i) Setting up an Extension Centre of the Centre for Electronics Designs & Training.

The Department of Electronics (DOE) Govt of India, intended to set up an Extension Centre of the Centre for Electronics Designs & Training in Meghalaya for providing employment oriented training in Electronics. DOE was of the view that the proposed centre could be set up under NEHU. The Government of Meghalaya has agreed to the suggestion as has been informed by the Principal Secretary, Planning, Govt of Meghalaya.

Accordingly, the matter was taken up by the University and Dr D.T.Khathing, Prof & Head, RSIC, was authorised to take necessary action in this regard and collect necessary information to establish the Centre.

Dr Khathing had a discussion with the DOE officials in Delhi and reported as under:

The Centre for Electronics Design & Technology of India (CEDTI) is an autonomous scientific society under the department of Electronics, Govt of India with headquarters at New Delhi.

The objectives of the CEDTI, are:

1. To train manpower in Electronics Product Design, Manufacturing, Maintenance and Information Technology.
2. To develop entrepreneurs and designers in Electronics.
3. To maintain close links with Institutes, R & D Centres and Consultancy.
4. To undertake Product Development, contract Research and Consultancy.

CEDTI is keen to establish its Extension Centre in Meghalaya to provide employment oriented training in Electronics. DOE was of the view that the proposed Centre could be set up in NEHU.

While CEDTI would be forth coming in giving most of the financial support and guidance for setting up of such centre, it would need to know the involvement/support that would be forth coming from NEHU. Three general areas of support was identified:

- a) Infrastructure - building.
- b) Equipment & Laboratory units.
- c) Recurring including salaries.

The CEDTI would fully support (b) & much of (a) & (c). However, it would need to know how much support the host institute would be able to commit for items (a) & (c). CEDTI also need to know under whose control and management the Extension Centre would be under NEHU

In case the Council decides to accept the proposal, it may identify the controlling authority who maybe entrusted with the responsibility for the control and management of the Centre.

In regard to support, the university may agree to provide temporary accommodation only if the requirement of space is nominal in terms of size; but no financial expenditure can be borne by the university as there is no such provision in our plan or non-plan budget.

Comments from DR D.T.Khathing, RSIC and Prof Man Mohan Singh, Science Education, along with report from Dr D. Khathing and the letter from the Principal Secretary, Planning, Govt. of Meghalaya are in Annexures A, B, C & D respectively.

Report on meeting with DOE Officials regarding the Establishment of a Centre for Electronics Design and Technology at NEHU

The Centre for Electronics Design and Technology of India (CEDTI) is an Autonomous Scientific Society under the Department of Electronics, Government of India with Headquarters at New Delhi. It operates seven Institutes located at Aurangabad, Calcutta, Gorakhpur, Imphal, Mohali, Srinagar/Jammu and Tezpur. It offers training to 250 students through formal long term training programmes and more than 2500 students through short term courses annually.

The objectives of CEDTI are -

- to train manpower in Electronics Product Design, Manufacturing, Maintenance and Information Technology.
- to develop entrepreneurs and designers in electronics.
- to maintain close links with Institutes, R&D Centres and academic institutions.
- to undertake Product Development, Contract Research and Consultancy.

The Centres already established have Thrust Areas and Training Programmes. Thrust areas can range from Agri-electronics, Instrumentation, Manufacturing Technology, Medical Electronics to Telecommunication, Office Automation and Information Technology. Training Programmes includes Long Term programmes like M.Tech in Electronics Design & Technology, Post Matric Diploma in Electronics Engineering to DOEACC 'A' and 'B' level courses. Short term programmes range from Computer Software and hardware based courses to PCB Assembly/Fabrication, Fiber Optic Techniques and Application.

Laboratory Facilities are available for each of the courses which includes computers, test and measuring equipment, repair and service of PCs, Radio, TV & Communication Labs and software application packages.

In the North East two Centres established are at Imphal (1987) and Tezpur University, Tezpur (1997). The Thrust Areas are General Electronics at Imphal and Agricultural Electronics (for tea Industry) and Electronics for Geological resources at Tezpur. The long term courses offered are Post Matric Diploma in Electronics Engineering and DOEACC 'O' and 'A' level at Imphal and Diploma in Electronics Design, Production and Maintenance and Certificate Course in Software Technology, at Tezpur. The short term courses include Micro-processors and its applications, Visual C++ tools, Repair of PC, CTV, etc., PCB Design & Fabrication, Desk Top Publishing and Application of Computers

Two new Centres have been approved to be established in the North East, one in Meghalaya and the other in Mizoram.

Meghalaya: The Professor & Head, Regional Sophisticated Instrumentation Centre, Shillong on behalf of NEHU, met with Shri R.S.Khandpur, Director General CEDTI, Govt. of India at New Delhi on the 25th August, 1998.

CEDTI is keen to establish its Extension Centre in Meghalaya to provide employment oriented training in Electronics. DOE was of the view that the proposed Centre could be set up under NEHU. The State Government has agreed to the suggestion.

A. While the CEDTI would be forth coming in giving most of the financial support and guidance for setting up of such Centre, it would need to know the involvement/ support that would be forth coming from NEHU or the State Government of Meghalaya or both. Three general areas of support were identified -

- (a) Infrastructure - building
- (b) Equipment & laboratory units
- (c) Recurring including salaries

The CEDTI would fully support (b) and much of (a) and (c). However it would need to know how much support the host Institute/State Government would be able to commit for items (a) & (c)

1) Placement of the P.U.C. teachers opting to remain in NEHU consequent upon the formation of the Central University in Mizoram. The Pachhunga University College Teachers' Association has submitted a memorandum (copy enclosed at Annexure A) on Placement of PUC Teachers in NEHU. The PUCTA urges that those teachers of the PUC who would opt to remain in the service of the NEHU after the formation of the Central University in Mizoram, be placed in its corresponding post graduate departments in Shillong.

The Council while deliberating on the issue may take note of the following:

1. Academic Council did not agree for retrenchment of any teacher of the PUC in the event of Mizoram University coming up.
2. So far no college in Meghalaya has been taken over by NEHU as its constituent college as the MHRD and the UGC did not favour for such a move.
3. So far no infrastructural facility is available for having a constituent college of NEHU in Meghalaya.
4. Given a choice, it is not possible that every teacher of PUC will opt for NEHU and as such it will not be feasible to start a department in any college with these few teachers only. The problems in such cases have already been experienced when few teachers from the department of Linguistics, Commerce & Geology from Nagaland University had opted for NEHU service.
5. The recruitment criteria for PUC teachers and the teachers for University P.G. departments are the same so far as qualifications etc. are concerned. Further, the composition of the Selection Committee also the same excepting for those who had been recruited before the taking over of P.U. College by NEHU.

In view of the above and also the facts as stated in the memorandum it may be considered by the Council to consider the representation of the PUC teachers.

Sir,

We may be permitted to draw your benevolent attention to the issue of the placement of those teachers of the Pachhunga University College(PUC) who would opt to remain in the service of the North Eastern Hill University(NEHU) in the event of the establishment of the Central University in Mizoram.

Sir, the matter is of paramount importance to us being the determinant of our career and future security. Consequently, over the last three years, since the issue first came up, the members of our Association(the PUCTA) have been contemplating and speculating over the various possibilities of the said placement Vis-a-Vis the NEHU. Those speculations were the contents of our representations made until recently on the issue to the concerned authorities, the referred one being the last in the series. Nevertheless, the exigence of the issue has considerably shot up in recent times in view of the fact that the Mizoram Central University is now indeed oncoming. Hence the members of PUCTA have paid serious attention into the matter for evolving a final resolution on the issue.

Sir, we have discussed afresh and at length the various aspects of the said issue in a general body meeting of the PUCTA held very recently. the deliberations made in that meeting have converged on the unequivocal conclusions made in the placement issue, that is, "the teachers who would opt to remain in the NEHU service be placed in the Post-Graduate departments in Shillong". A memorandum conveying our contention about the placement issue and its related aspects is attached hereto for your kind perusal and judicious action.

MEMORANDUM OF PUCTA ON PLACEMENT OF PUC TEACHERS IN NEHU

We may kindly be allowed to submit the following on the present issue for your kind and active consideration.

1. The PUCTA urges that those teachers of the Pachhunga University College(PUC) who would opt to remain in the service of the North Eastern Hill University(NEHU) after the formation of the Central University in Mizoram be placed in its corresponding Post Graduate department in Shillong. In the cases of the subject for which such departments may not be in existence, the teachers ought to be placed in the allied Post Graduate departments or in the related centres of study, if creation of such departments is deemed unfeasible, but again in Shillong.

2. The PUCTA is of the opinion that such placement of teachers as mentioned above in serial No.1 can easily be done by adjusting the concerned teachers against the regular vacancies and, if necessary, by creating or by arranging to carry the required number of personal posts, whichever is found suitable.

The proposed placement is justified by the following facts:

i) This would benefit qualifications of the teachers in terms of the UGC norms as well as the experiences.

ii) This would give us an access to the facilities of already established set up, which we have deprived of so far, and which we were confident would now enable us to excel ourselves academically, professionally and intellectually and hence to contribute more to the NEHU.

iii) This would certainly add to the strength of each departments in the NEHU and thereby help enrich its academic programmes to cope with the rapid expansion of knowledge, thus elevating NEHU's position in the national level.

iv) This would be cost-effective to the maximum, entailing no significant additional exchequer because of requirements of not much infra-structural development for the purposes of the proposed placement.

3. The PUCTA further urges that all the necessary arrangements be completed well in advance, so that the said placement of the teachers can be carried out soon after the exercise of option by them. And, before that, the process of option exercise ought to be completed as soon as the notification of the Mizoram Central University Act. is made by the Government of India. In any case, the process of placement in the NEHU must not be prolonged to the disadvantage of the concerned incumbents.

In the light of the above submission, we fervently request your kindness to be gracious enough to exert your good office to ensure justice for us.

- 1i) Application for posts in respect of faculty members within the University during the probationary period.

A request have been received from faculty member of the University that they be allowed to apply the post advertised by the University during the probationary period.

In this context, the 12th EC Resolution No.EC:12:76:79 at Para (i) at (Annexure I) had decided that application for posts outside the University should be routed through proper channel. Secondly, no member of the staff shall be permitted to apply for a post during the period of probation or within the first two years of his appointment whichever is later. The EC is completely silent for whether the above decision is also binding on University teachers who would like to apply for another post advertised in other Departments of the University.

However, the restriction imposed at Para (ii) of the said EC decision on its applicability of the probationary period in principle have to be completed before being eligible for applying any posts whether departmental or external.

The matter is placed before the Academic Council for a decision.

With reference to the letter cited above, marked to me for examining and comments and also on your advice having met Mr. R. Lyngdoh, the Proposer of the project on Science & Technology, and had discussion with Dr. D.T. Khathing, Dr. S. Aravamudhan and some other colleagues, following are my submissions:-

- * Mr. R. Lyngdoh is a young man of mid twenties. He wants to establish Discovery Science Exhibition at Glory's Plaza for social marketing of science by beginning an enterprise, which is self reliant and committed to social responsibility for popularisation of science.
- * He has a place, resources, business potential and perhaps understanding of no-profit business and marketing, as he expressed.
- * He is making a request to the University to provide technical backup and support to install Discovery Science Participatory Exhibition at Glory's Plaza in any of the following manner and conditions suitable to the University.

Long Term Collaboration with payment of consultation and royalty.

Turn key project for implementation, which includes design, development & installation of the Discovery Science Participatory Exhibition with exclusive responsibility of Para Ri Enterprise to run the same on their own risk.

Provide on payment Discovery Science Exhibits to Glory's Plaza for them to install and begin the activity.

In any case, the credit to the university for providing such a help will be gratefully acknowledged publically. Moreover, the Proposer is prepared to contribute a token proceeds towards his gratitude to the University for this help.

Since, this is a request of unprecedented nature, the University may need to discuss the following in the EC and advice accordingly.

- * The proposed Science activity for joy and fun of Science is to be installed in a commercial place.
- * It has to be self reliant and viable therefore will be marketed socially on no-profit no-loss bases. That means entry ticket like that of Science Centres will be levied to recover working costs.
- * Not withstanding natural hazards of social marketing if any, of which I am not aware of, I find,

Proposal is a step forward from community to fulfill constitutional obligation under Article 51A(h)

The offer interesting and worth consideration Besides involving business enterprise for science inputs to community at commercial place is an imperative necessity which may need to be encouraged.
