

- (xvii) Acceptance of technical resignation of Dr. G. Sengupta, Reader, Department of History, NEHU, Shillong.

Dr. Gautam Sengupta joined NEHU as Reader in the Department of History, NEHU, Shillong with effect from 2.9.1985.

During his service in NEHU, he has been allowed to join the post of the Director of Archaeology under the Department of Information & Culture, Government of West Bengal on foreign service terms and conditions with effect from 31.7.90 (AM) initially for a period of one year.

Later, the extension of his deputation has been allowed for another period of one year with effect from 31.7.91 and subsequently for another period of six months from 1.8.92 to 31.1.93.

Dr. Sengupta informed that the Government of West Bengal has decided to absorb him on regular basis to the above post.

Since the Executive Council vide resolution No:EC:76:92:6:03(v) dated 14.8.92 resolved that no further extension would be allowed in his case beyond 31.1.93, the Office requested Dr. Sengupta to submit his technical resignation from the University with effect from 1.2.93 (FN).

Dr. Gautam Sengupta tendered his technical resignation (through proper channel) from the University with effect from 1.2.93 (FN) and the Vice-Chancellor has accepted his technical resignation.

The Leave Salary and Pension Contribution for the deputation period with effect from 1.8.90 to 31.1.93 have been received by the University from the Government of West Bengal.

The matter is placed to the Council for ratification.
