

- (vi) Acceptance of resignation of Dr Larisha M.Lyndem, Lecturer in the Department of Rural Development and Agricultural Production, NEHU, Tura Campus, Tura. 26

Dr Larisha M.Lyndem joined this University as Lecturer in the Department of Rural Development and Agricultural Production, NEHU, Tura Campus, Tura on 21.12.2006 (AN). On 4th May, 2007, Dr Lyndem submitted her letter of resignation from the post of Lecturer in the Department of Rural Development and Agricultural Production on personal ground and requested the University to release her from the post w.e.f 8th May, 2007. The letter dated 4th May, 2007 from Dr Lyndem is placed at **Annexure-A**. Again Dr Lyndem, through her letter dated 7th May, 2007 informed that under the prevailing extra ordinary situation, she may be relieved from the services of the University w.e.f 8th May, 2007 and requirement of three months notice may be condoned. This has duly been recommended by the Pro-Vice Chancellor, NEHU, Tura Campus, Tura. The letter dated 7th May, 2007 from Dr Lyndem may be seen at **Annexure-B**.

The Vice Chancellor in accordance with the provision laid down under OE-5 vide Clause -11 has accepted the resignation tendered by Dr Lyndem w.e.f 8th May, 2007 (FN). The provision as laid down under OE-5 vide Clause-11 is re-produced below:-

“A teacher may, at any time, terminate his engagements by giving the Executive Council three months notice in writing. Provided that the Executive Council may waive the requirement of notice at its discretion. Provided further that if the notice period ends in the middle of academic semester and if the leaving of the teacher is likely to affect the teaching work, the teacher may be released only at the end of the semester in the case of the university teachers and at the end of the academic session in the case of the constituent colleges”

Dr Lyndem was informed of the acceptance of her resignation vide order No.F.19-431/Estt.II/2006-303 dated 7th May, 2007 (**Annexure-C**).

The matter is, therefore, placed before the Council to condone three months notice period and ratify the action taken by the Vice Chancellor in accepting the resignation of Dr Lyndem.

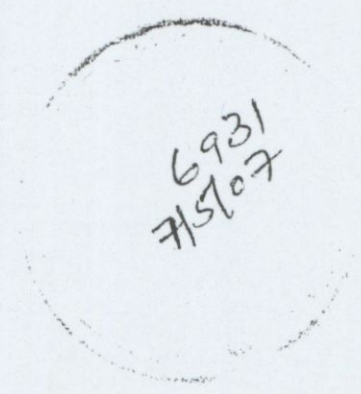
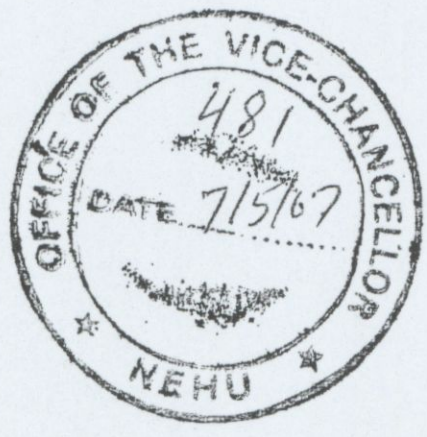


